Responsible Care: Fecc's Contribution to Sustainability

Responsible Care is the global chemical industry's unique initiative to improve health, safety, security and **environmental performance**, and communicate with stakeholders about products and processes.²

Within *Fecc*, Responsible Care commits member National Associations and member companies to comply with the **Eight Guiding Principles**: Legal Requirements, Management of Risk, Policies & Documentation, Provision of Information, Training, Emergency Response, On-going Improvements and Community Interaction which, put in practice, can be considered as **long-standing sustainability actions** in the framework of Responsible Care.

Sustainability is a key part of the chemical distributors' business model, and guides their activities in their interaction with manufacturers and downstream users. The issues of health, safety, security and environmental protection (HSSE) are deeply embedded in *Fecc*'s members' corporate culture – as cornerstones of their responsibility to their employees, customers and suppliers, as well as to the local communities in which they operate.

As a consequence, key elements of **Sustainability** and **Corporate Social Responsibility** (**CSR**) have been incorporated into SQAS/ESAD (European Single Assessment Document) in 2015, including criteria on the Environment (ESAD DI Section 1.4.2, 3.5, etc.), Labour Policy and Human Rights (ESAD DI Section1.2, 2.8, etc.) and Fair Business Practice (ESAD DI Section 2.9 etc.).

Many chemical distributors have historically taken proactive actions which are recognized as meeting the criteria of sustainable development. The use of **returnable**, **reusable packaging** and **packageless** delivery are just two examples of such actions that have been introduced over a period of many years, reducing both raw material consumption and material entering the waste stream. Another positive action is the **optimisation** of distribution movements,

which has ensured that distribution is carried out in a more fuel-efficient manner. Modern and advanced driver training have also helped to **reduce fuel use and emissions** from each vehicle.

Other initiatives such as the **recycling of used products** and **chemical leasing** are increasingly being explored by distributors as a valuable contribution to circular economy.

Responsible Care: A Driver for Sustainability

Responsible Care, as practiced within the chemical distribution sector, goes historically beyond legislation and contributes to the "three pillars of sustainability" (environment, society and economy). In this context, chemical distributors strive to strike an appropriate balance between business, ecology and social issues and reconciling these different priorities.

We, the European chemical distribution industry, call upon our members, National Associations, stakeholders and policymakers to join us in **continuing our efforts within the Responsible Care framework** to create economic, environmental and social value as our contribution to sustainability.
